Updates- Impact Analysis/Outreach

- ▶ Total agencies contacted: 221
 - ▶ 46 agencies still need contact
- ▶ Impact Estimate: 106 agencies were able to report impact estimate
(# impacted/# served In voc. Hab service)
- ▶ Impact ranged from 2% to 100%
- ▶ Average impact: 53%
